ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order Imposing Administrative Penalty against Student CU Connect CUSO LLC (“Student CU”).¹

Statement of Facts and Law

Student CU is a regulated lender licensed by the OCCC under Chapter 342 of the Texas Finance Code. Student CU operates under master file number 15412 at one licensed location, under license number 57434. Student CU’s compliance officer is Tony Ferris, and its designated contact address is 8575 W. 110th St., Ste. 220, Overland Park, Kansas 66210.

A regulated lender must file annual reports with the Consumer Credit Commissioner (“Commissioner”).² A regulated lender must file the required annual report by May 1 for the prior year’s calendar loan activity on forms prescribed by the Commissioner and must comply with all instructions relating to submitting the report.³

On May 25, 2016, the OCCC issued an Order to File Timely and Accurate Annual Reports against Student CU for failing to timely file its 2015 annual report. Student CU did not request a hearing on the Order, and a Final Order was issued on July 14, 2016. The Order required Student CU to timely file complete and accurate future annual reports.

Student CU did not file its 2018 annual report with the Commissioner on or before May 1, 2019.

Order

IT IS ORDERED that Student CU Connect CUSO LLC:

1. pay an administrative penalty in the amount of \$500.00 (calculated as \$500.00 each for Student CU's one licensed location), within 30 days of service of this Order; and
2. file its 2018 annual report within 30 days of service of this Order, if it has not already done so.

Regulated lender annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occ.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occ.texas.gov.

Response and Right to Request Hearing

You have the right to request a hearing regarding this Order.⁴ Your request must be made in writing and sent to the OCCC not later than 30 days after you receive this Order. You must send your request to:

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.⁵ If you fail to request a hearing by this deadline, this Order is considered final and enforceable.⁶
