ORDER TO MAINTAIN MINIMUM NET ASSETS NUNC PRO TUNC

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order to Maintain Minimum Net Assets Nunc Pro Tunc against BSS Solutions, LLC (“BSS Solutions”).¹

Clerical Error

This Nunc Pro Tunc Order is issued by the OCCC to correct a clerical error in the original Order to Maintain Minimum Net Assets that was served on BSS Solutions on April 11, 2019. In footnotes 4, 5 and 6, the original order cites implementing rules for a net asset violation in Title 7 Texas Administrative Code Section 89.301(1). The corrected citation for implementing rules for regulated lenders is Title 7 Texas Administrative Code Section 83.301(1). Footnotes 7, 8, and 9 now cite Title 7 Texas Administrative Code Section 83.301(1).

A Nunc Pro Tunc Order may be issued to correct a clerical error.² Although a Nunc Pro Tunc Order is signed after an original order, the effect of a Nunc Pro Tunc Order relates back to the date the original order was signed.³ Therefore, any deadlines from the original order remain in place. If you fail to request a hearing by the deadline identified in the original Order dated April 11, 2019, this Order is considered final and enforceable.⁴

Statement of Facts and Law

BSS Solutions is a regulated lender licensed by the OCCC under Chapter 342 of the Texas Finance Code. BSS Solutions operates under master file number 1600054832 at one licensed location, under license number 154898. BSS Solutions's compliance officer is Jonathan Blanco, and its designated contact address is 6731 Path Way Ct., Katy, Texas 77449.

A regulated lender must report its minimum net asset within its annual reports with the Consumer Credit Commissioner ("Commissioner").⁵ A regulated lender must maintain for each office for which a license is held net assets of at least \$25,000 that are used or readily available for use in conducting the business of that office.⁶

Net assets are the total value of acceptable assets used or designated as readily available for use in the business, less liabilities, other than those liabilities secured by unacceptable assets.⁷ Unacceptable assets include, but are not limited to, goodwill, unpaid stock subscriptions, lines of credit, notes receivable from an owner, property subject to the claim of homestead or other property exemption and encumbered real or personal property to the extent of the encumbrance.⁸ Generally, assets are available for use if they are readily convertible to cash within 10 business days.⁹

The balance sheet submitted by BSS Solutions with its 2017 annual report shows the company has a net asset that is below the requirement. On September 5, 2018, the OCCC sent a letter to BSS Solutions instructing to either correct the balance sheet if an error was made, or to transfer enough assets to the business to meet the net assets requirement. The letter instructed BSS Solutions to submit a corrected balance sheet and documentation supporting all changes by October 5, 2018.

BSS Solutions submitted a corrected 2017 annual report on September 28, 2018. The OCCC notified BSS Solutions on September 28, 2019, that its corrected report did not show the required asset amount and did not explain the changes

made from its previous submission. BSS Solutions submitted another corrected report on February 27, 2019. The OCCC followed up on the same day with additional questions and concerns regarding the net assets reported in the corrected report. As of the date of this Order, the OCCC has not received a response to its inquiry or evidence of compliance with the net asset requirement.

The Commissioner may issue an injunction ordering a regulated lender to report and maintain the required net asset minimum if the Commissioner has reasonable cause to believe that the regulated lender is violating Chapter 342 of the Texas Finance Code.¹⁰ The Commissioner has reasonable cause to believe that BSS Solutions is violating Chapter 342 of the Texas Finance Code, and therefore issues this Order, because BSS Solutions failed to maintain minimum net asset requirements.

Order

IT IS ORDERED that BSS Solutions, LLC:

1. cease and desist from violating, and comply with the requirements set forth in 342.153(a) of the Texas Finance Code;
2. submit a new balance sheet with documents supporting all changes within 30 days of service of this Order, if it has not already done so; and
3. file timely, complete, and accurate annual reports reflecting compliance with the minimum net asset requirement.

Violation of Order

You may be assessed an administrative penalty of up to \$1,000 for each day of violation of this Order.¹¹ Multiple violations may also result in the suspension or revocation of your license.¹²

Right to Request Hearing

You have the right to request a hearing regarding this Order.¹³ Your request must be made in writing and sent to the OCCC not later than 30 days after you receive this Order. You must send your request to:

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.¹⁴ If you fail to request a hearing by this deadline, this Order is considered final and enforceable.¹⁵
