# ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Imposing Administrative Penalty against Circle Seven Corp Crosby Inc. d/b/a CIRCLE PAWN # 8 ("Circle Pawn").1

#### Statement of Facts and Law

Circle Pawn is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. Circle Pawn operates under master file number 2980 at two licensed locations, under license numbers 3683 and 6935. Circle Pawn's compliance officer is Braxton Roberts Sr., and its designated contact address is P.O. Box 4392, Pasadena, Texas 77502.

A pawnshop must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> A pawnshop must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>3</sup> For each pawnshop licensed location, a pawnshop must file an annual report by July 31 for the prior calendar year's activity, and must comply with all instructions relating to submitting the report.<sup>4</sup>

Circle Pawn did not file its 2018 annual report with the Commissioner for licensed location numbers 3683 and 6935 by July 31, 2019.

On December 6, 2018, the OCCC issued an Injunctive Order to File Timely and Accurate Annual Reports (the "Order") against Circle Pawn for violating Chapter 371 of the Texas Finance Code by failing to timely file its 2017 annual report. The Order required Circle Pawn to timely file all future annual reports.

Circle Pawn did not file its 2018 annual report with the Commissioner for licensed location numbers 3683 and 935 by July 31, 2019. Circle Pawn violated the Order by failing to timely file its 2018 annual report and is therefore subject to an administrative penalty for violation of the Order.<sup>5</sup>

# Order

IT IS ORDERED that CIRCLE SEVEN CORP CROSBY INC. d/b/a CIRCLE PAWN # 8:

- 1. pay an administrative penalty in the amount of **\$1000**, calculated as \$500.00 each for Circle Pawn's two licensed locations, within 30 days of service of this Order; and
- 2. file its 2018 annual report within 30 days of service of this Order, if it has not already done so.

Pawnshop annual reports must be submitted either by mail to 2601 N. Lamar Blvd., Austin, Texas 78705, or through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.
