# ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Imposing Administrative Penalty against Kenneth Bishop d/b/a B6UP Pawn and Gun ("B6UP Pawn").<sup>1</sup>

#### Statement of Facts and Law

B6UP Pawn is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. B6UP Pawn operates under master file number 18405 at one licensed location, under license number 66907. B6UP Pawn's compliance officer is KENNETH BISHOP, and its designated contact address is 720 Culver Street, Commerce, Texas 75428.

A pawnshop must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> A pawnshop must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>3</sup> For each pawnshop licensed location, a pawnshop must file an annual report by July 31 for the prior calendar year's activity, and must comply with all instructions relating to submitting the report.<sup>4</sup>

B6UP Pawn did not file its 2018 annual report with the Commissioner for licensed location number 66907 by July 31, 2019.

On November 13, 2017, the OCCC issued an Injunctive Order to File Timely and Accurate Annual Reports (the "Order") against B6UP Pawn for violating Chapter 371 of the Texas Finance Code by failing to timely file its 2016 annual report. The Order required B6UP Pawn to timely file all future annual reports.

B6UP Pawn did not file its 2018 annual report with the Commissioner for licensed location number 66907 by July 31, 2019. B6UP Pawn violated the Order by failing to timely file its 2018 annual report and is therefore subject to an administrative penalty for violation of the Order.<sup>5</sup>

### Order

IT IS ORDERED that Kenneth Bishop d/b/a B6UP Pawn and Gun:

- 1. pay an administrative penalty in the amount of \$500, calculated as \$500.00 each for B6UP Pawn's one licensed location, within 30 days of service of this Order; and
- 2. file its 2018 annual report within 30 days of service of this Order, if it has not already done so.

Pawnshop annual reports must be submitted either by mail to 2601 N. Lamar Blvd., Austin, Texas 78705, or through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.
