ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order Imposing Administrative Penalty against Charlie Callis d/b/a CR Callis Loan Company (“Callis Loan”).¹

Statement of Facts and Law

Callis Loan is a regulated lender licensed by the OCCC under Chapter 342 of the Texas Finance Code. Callis Loan operates under master file number 12915 at one licensed location, under license number 1122. Callis Loan’s compliance officer is Charlie Roberty Callis, Jr., and its designated contact address is 1112 S. Cameron St., Victoria, Texas 77901.

A regulated lender must file annual reports with the Consumer Credit Commissioner (“Commissioner”).² A regulated lender must file the required annual report by May 1 for the prior year’s calendar loan activity on forms prescribed by the Commissioner and must comply with all instructions relating to submitting the report.³

On May 26, 2016, the OCCC issued an Order to File Timely and Accurate Annual Reports against Callis Loan for failing to timely file its 2015 annual report. Callis Loan did not request a hearing on the Order, and a Final Order was issued on July 14, 2016. The Order required Callis Loan to timely file complete and accurate future annual reports.

Callis Loan did not file its 2018 annual report with the Commissioner on or before May 1, 2019.

Order

IT IS ORDERED that Charlie Callis d/b/a CR Callis Loan Company:

3. pay an administrative penalty in the amount of **\$1,000.00** (calculated as \$1,000.00 each for Callis Loan's one licensed location), within 30 days of service of this Order; and
4. file its 2018 annual report within 30 days of service of this Order, if it has not already done so.

Regulated lender annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occ.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occ.texas.gov.

Response and Right to Request Hearing

You have the right to request a hearing regarding this Order.⁴ Your request must be made in writing and sent to the OCCC not later than 30 days after you receive this Order. You must send your request to:

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.⁵ If you fail to request a hearing by this deadline, this Order is considered final and enforceable.⁶
