## ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Imposing Administrative Penalty against BL Cate d/b/a Hill County Pawn Shop ("Hill County Pawn Shop").¹

### Statement of Facts and Law

Hill County Pawn Shop is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. Hill County Pawn Shop operates under master file number 11028 at one licensed location, under license number 8177. Hill County Pawn Shop's compliance officer is Bl Cate, and its designated contact address is 105 E. Walnut, Hillsboro, Texas 76645.

A pawnshop must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> For each pawnshop licensed location, a pawnshop must file an annual report by July 31 for the prior calendar year's activity, and must comply with all instructions relating to submitting the report.<sup>3</sup>

Hill County Pawn Shop did not file its 2019 annual report with the Commissioner for one licensed location, under license number 8177 by July 31, 2020.

On October 21, 2019, the OCCC issued an Order to File Timely and Accurate Annual Reports (the "Order") against Hill County Pawn Shop for violating Chapter 371 of the Texas Finance Code by failing to timely file its 2018 annual report. The Order required Hill County Pawn Shop to timely file all future annual reports.

Hill County Pawn Shop did not file its 2019 annual report with the Commissioner for one licensed location, under license number 8177, by July 31, 2020. Hill County Pawn Shop violated the Order by failing to timely file its 2019 annual report and is therefore subject to an administrative penalty for violation of the Order.<sup>4</sup>

#### Order

IT IS ORDERED that BL Cate d/b/a Hill County Pawn Shop:

- 1. pay an administrative penalty in the amount of \$500.00, calculated as \$500.00 each for Hill County Pawn Shop's one licensed location, within 30 days of service of this Order; and
- 1. file its 2019 annual report within 30 days of service of this Order, if it has not already done so.

Pawnshop annual reports must be submitted either by mail to 2601 N. Lamar Blvd., Austin, Texas 78705, or through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.
