## ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Imposing Administrative Penalty against A-Team Auto Finance LLC ("A-Team Auto Finance").<sup>1</sup>

## Statement of Facts and Law

A-Team Auto Finance is a regulated lender licensed by the OCCC under Chapter 342 of the Texas Finance Code. A-Team Auto Finance operates under master file number 14941 at one licensed location, under license number 56549. A-Team Auto Finance's compliance officer is Steve Clohessy, and its designated contact address is 11626 E. NW Hwy., Dallas, Texas 75218.

A regulated lender must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> A regulated lender must comply with all instructions from the OCCC relating to submitting the report.<sup>3</sup> The report is due by May 1 of each year for the prior calendar year's loan activity.<sup>4</sup> For 2019 annual reports, the OCCC allowed 31 additional days (until June 1, 2020) for regulated lenders to file reports.

On July 9, 2018, the OCCC issued an Injunctive Order to File Timely and Accurate Annual Reports against A-Team Auto Finance for failing to timely file its 2017 annual report. A-Team Auto Finance did not request a hearing on the Order, and the Order became final and enforceable. The Order required A-Team Auto Finance to timely file complete and accurate future reports.

A-Team Auto Finance did not file its 2019 annual report with the Commissioner on or before June 1, 2020.

The Commissioner may issue an injunction ordering a regulated lender to file one or more complete, accurate, and timely annual reports if the Commissioner has reasonable cause to believe that the regulated lender is violating Chapter 342 of the Texas Finance Code.<sup>5</sup> The Commissioner may impose an administrative penalty on a regulated lender that violates an injunction.<sup>6</sup>

By failing to timely file its 2019 annual report, A-Team Auto Finance has violated Chapter 342 of the Texas Finance Code and the OCCC's Injunctive Order to File Timely and Accurate Annual Reports.

#### Order

IT IS ORDERED that A-Team Auto Finance LLC:

- 1. pay an administrative penalty in the amount of \$500.00, calculated as \$500.00 each for A-Team Auto Finance's one licensed location, within 30 days of service of this Order; and
- 2. file its 2019 annual report within 30 days of service of this Order, if it has not already done so.

Regulated lender annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.

# **Right to Request Hearing**

You have the right to request a hearing regarding this Order. To request a hearing, you must send a written hearing request to the OCCC no later than 30 days after service of this Order. If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code. If you fail to request a hearing by the deadline, this Order will be considered final and enforceable.
