ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Imposing Administrative Penalty against Empire Motor Cars Inc. d/b/a Empire RV & Marine ("Empire RV & Marine").¹

Statement of Facts and Law

Empire RV & Marine is a regulated lender licensed by the OCCC under Chapter 342 of the Texas Finance Code. Empire RV & Marine operates under master file number 1700058738 at one licensed location, under license number 159058. Empire RV & Marine's compliance officer is Ali Zolfaghari, and its designated contact address is 2801 N. Main St., Liberty, Texas 77575.

A regulated lender must file annual reports with the Consumer Credit Commissioner ("Commissioner").² A regulated lender must comply with all instructions from the OCCC relating to submitting the report.³ The report is due by May 1 of each year for the prior calendar year's loan activity.⁴ For 2019 annual reports, the OCCC allowed 31 additional days (until June 1, 2020) for regulated lenders to file reports.

On August 21, 2019, the OCCC issued an Order to File Timely and Accurate Annual Reports against Empire RV & Marine for failing to timely file its 2018 annual report. Empire RV & Marine did not request a hearing on the Order, and the Order became final and enforceable. The Order required Empire RV & Marine to timely file complete and accurate future reports.

Empire RV & Marine did not file its 2019 annual report with the Commissioner on or before June 1, 2020.

The Commissioner may issue an injunction ordering a regulated lender to file one or more complete, accurate, and timely annual reports if the Commissioner has reasonable cause to believe that the regulated lender is violating Chapter 342 of the Texas Finance Code.⁵ The Commissioner may impose an administrative penalty on a regulated lender that violates an injunction.⁶

By failing to timely file its 2019 annual report, Empire RV & Marine has violated Chapter 342 of the Texas Finance Code and the OCCC's Order to File Timely and Accurate Annual Reports.

Order

IT IS ORDERED that Empire Motor Cars Inc. d/b/a Empire RV & Marine:

- 1. pay an administrative penalty in the amount of \$500.00, calculated as \$500.00 each for Empire RV & Marine's one licensed location, within 30 days of service of this Order; and
- 2. file its 2019 annual report within 30 days of service of this Order, if it has not already done so.

Regulated lender annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.

You have the right to request a hearing regarding this Order. To request a hearing, you must send a written hearing request to the OCCC no later than 30 days after service of this Order. If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code. If you fail to request a hearing by the deadline, this Order will be considered final and enforceable.
