**ORDER IMPOSING ADMINISTRATIVE PENALTY**

The Office of Consumer Credit Commissioner (“OCCC”) issues this Order Imposing Administrative Penalty against North Texas Pawn & Gun, Inc. (“North Texas Pawn & Gun”).<sup>1</sup>

**Statement of Facts and Law**

North Texas Pawn & Gun is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. North Texas Pawn & Gun operates under master file number 1600056424 at one licensed location, under license number 156411. North Texas Pawn & Gun’s compliance officer is Michael S. Goolsby, and its designated contact address is 214 E. Hwy 82, Nocona, Texas 76255.

A pawnshop must file annual reports with the Consumer Credit Commissioner (“Commissioner”).<sup>2</sup> For each pawnshop licensed location, a pawnshop must file an annual report by July 31 for the prior calendar year’s activity, and must comply with all instructions relating to submitting the report.<sup>3</sup>

North Texas Pawn & Gun did not file its 2019 annual report with the Commissioner for one licensed location, under license number 156411 by July 31, 2020.

On December 6, 2018, the OCCC issued an Injunctive Order to File Timely and Accurate Reports (the "Order") against North Texas Pawn & Gun for violating Chapter 371 of the Texas Finance Code by failing to timely file its 2017 annual report. The Order required North Texas Pawn & Gun to timely file all future annual reports.

North Texas Pawn & Gun did not file its 2019 annual report with the Commissioner for one licensed location, under license number 156411, by July 31, 2020. North Texas Pawn & Gun violated the Order by failing to timely file its 2019 annual report and is therefore subject to an administrative penalty for violation of the Order.<sup>4</sup>

### **Order**

IT IS ORDERED that North Texas Pawn & Gun, Inc.:

1. pay an administrative penalty in the amount of **\$500.00**, calculated as \$500.00 each for North Texas Pawn & Gun's one licensed location, within 30 days of service of this Order; and
1. file its 2019 annual report within 30 days of service of this Order, if it has not already done so.

Pawnshop annual reports must be submitted either by mail to 2601 N. Lamar Blvd., Austin, Texas 78705, or through the OCCC's Application Licensing Examination and Compliance System (ALECS): [alecs.occ.texas.gov](http://alecs.occ.texas.gov). Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, [occ.texas.gov](http://occ.texas.gov).

## Response and Right to Request Hearing

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.<sup>6</sup> If you fail to request a hearing by this deadline, this Order is considered final and enforceable.<sup>7</sup>
