### ORDER TO FILE TIMELY AND ACCURATE ANNUAL REPORTS

The Office of Consumer Credit Commissioner ("OCCC") issues this Order to File Timely and Accurate Annual Reports against La Piedad Pawnshop #3 LLC ("La Piedad Pawnshop #3").<sup>1</sup>

#### Statement of Facts and Law

La Piedad Pawnshop #3 is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. La Piedad Pawnshop #3 operates under master file number 17339 at one licensed location, under license number 64318. La Piedad Pawnshop #3's compliance officer is Greg Young, and its designated contact address is 302 N. Grant St. US Hwy. 83, Roma, Texas 78584.

A pawnshop must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> A pawnshop must comply with all instructions from the OCCC relating to submitting the report, and must file a report for each licensed location.<sup>3</sup> The report is due by July 31 for the prior calendar year's activity.<sup>4</sup>

La Piedad Pawnshop #3 did not file its 2020 annual report by July 31, 2021, for one licensed location, under license number 64318.

The Commissioner may issue an injunction ordering a pawnshop to file one or more complete, accurate, and timely annual reports if the Commissioner has reasonable cause to believe that the pawnshop is violating Chapter 371 of the Texas Finance Code.<sup>5</sup>

The Commissioner has reasonable cause to believe that La Piedad Pawnshop #3 is violating Chapter 371 of the Texas Finance Code, and therefore issues this Order, because La Piedad Pawnshop #3 failed to timely file its 2020 annual report.

## Order

IT IS ORDERED that La Piedad Pawnshop #3 LLC:

- comply with, and cease and desist from violating, the reporting requirements set forth in 371.201 of the Texas Finance Code and Title 7, Section 85.502 of the Texas Administrative Code;
- 2. file its 2020 annual report within 30 days of the date of this Order, if it has not already done so; and
- 3. timely file complete and accurate future annual reports.

Pawnshop annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.

## Violation of Order

If you violate this Order, the OCCC may impose an administrative penalty of up to \$1,000 for each day.<sup>6</sup> Multiple violations may also result in the suspension or revocation of your license.<sup>7</sup>

# **Right to Request Hearing**

You have the right to request a hearing regarding this Order.<sup>8</sup> To request a hearing, you must send a written hearing request to the OCCC no later than 30 days after the date of this Order.<sup>9</sup> You must send your request to Matthew Nance, Deputy General Counsel, by mail to 2601 N. Lamar Blvd., Austin, Texas 78705, or by email to matthew.nance@occc.texas.gov.

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.<sup>10</sup> If you fail to request a hearing by the deadline, this Order will be considered final and enforceable.<sup>11</sup>
