#### ORDER TO FILE TIMELY AND ACCURATE QUARTERLY AND ANNUAL REPORTS

The Office of Consumer Credit Commissioner ("OCCC") issues this Order to File Timely and Accurate Quarterly and Annual Reports against Nine27 Group LLC d/b/a Family Financial Centers ("Nine27 Group").<sup>1</sup>

#### Statement of Facts and Law

Nine27 Group is a credit services organization licensed to act as a credit access business under Chapter 393 of the Texas Finance Code. Nine27 Group operates under master file number 2100069443 at one licensed location, under license number 166774. Nine27 Group's compliance officer is Emilio Garcia Caro, and its designated contact address is 14102 Cindywood Circle, Houston, Texas 77079.

A credit access business must file quarterly and annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> A credit access business must submit for each of its licensed locations its 2021 4th quarter and annual reports on or before January 31, 2022.<sup>3</sup> All information provided on the quarterly and annual reports must be accurate and calculated in accordance with the OCCC's instructions.<sup>4</sup>

Nine27 Group did not file its 2021 4th quarter and annual reports with the Commissioner on or before January 31, 2022.

The Commissioner may issue an injunction ordering a credit access business to file one or more complete, accurate, and timely quarterly or annual reports if the Commissioner has reasonable cause to believe that the credit access business is violating Chapter 393 of the Texas Finance Code.<sup>5</sup>

The Commissioner has reasonable cause to believe that Nine27 Group is violating Chapter 393 of the Texas Finance Code, and therefore issues this Order, because Nine27 Group failed to timely file its 2021 4th quarter and annual reports.

## Order

IT IS ORDERED that Nine27 Group LLC d/b/a Family Financial Centers:

- 1. comply with, and cease and desist from violating, the reporting requirements set forth in Section 393.627 of the Texas Finance Code and Title 7, Section 83.5001 of the Texas Administrative Code;
- 2. file its 2021 4th quarter and annual reports within 30 days of the date of this Order, if it has not already done so; and
- 3. timely file complete and accurate future quarterly and annual reports.

Credit access business quarterly and annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.

# Violation of Order

You may be assessed an administrative penalty of up to \$1,000 for each day of violation of this Order.<sup>6</sup> Multiple violations may also result in the suspension or revocation of your license.<sup>7</sup>

## **Right to Request Hearing**

You have the right to request a hearing regarding this Order.<sup>8</sup> Your request must be made in writing and sent to the OCCC no later than 30 days after the date of this Order. If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.<sup>9</sup> If you fail to request a hearing by this deadline, this Order is considered final and enforceable.<sup>10</sup>
