#### ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Imposing Administrative Penalty against RSMC Funds Inc. d/b/a Ron Self Motor Co ("Ron Self Motor").<sup>1</sup>

### Statement of Facts and Law

Ron Self Motor is a regulated lender licensed by the OCCC under Chapter 342 of the Texas Finance Code. Ron Self Motor operates under master file number 2913 at one licensed location, under license number 34061. Ron Self Motor's compliance officer is Ronald Self, and its designated contact address is 3500 Ne 28th St., Fort Worth, Texas, 76111.

A regulated lender must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> A regulated lender must comply with all instructions from the OCCC relating to submitting the report.<sup>3</sup> The report is due by May 1 of each year for the prior calendar year's loan activity.<sup>4</sup>

On October 12, 2020, the OCCC issued an Order to File Timely and Accurate Annual Reports against Ron Self Motor for failing to timely file its 2019 annual report. The Order became final and enforceable. The Order required Ron Self Motor to timely file complete and accurate future reports.

Ron Self Motor did not file its 2020 annual report with the Commissioner on or before May 1, 2021.

The Commissioner may issue an injunction ordering a regulated lender to file one or more complete, accurate, and timely annual reports if the Commissioner has reasonable cause to believe that the regulated lender is violating Chapter 342 of the Texas Finance Code.<sup>5</sup> The Commissioner may impose an administrative penalty on a regulated lender that violates an injunction.<sup>6</sup>

By failing to timely file its 2020 annual report, Ron Self Motor has violated Chapter 342 of the Texas Finance Code and the OCCC's Order to File Timely and Accurate Annual Reports.

# Order

IT IS ORDERED that RSMC Funds Inc. d/b/a Ron Self Motor Co:

- pay an administrative penalty in the amount of \$500.00, calculated as \$500.00 each for Ron Self Motor's one licensed location, within 30 days of service of this Order; and
- 2. file its 2020 annual report within 30 days of service of this Order, if it has not already done so.

Regulated lender annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.

# **Right to Request Hearing**

You have the right to request a hearing regarding this Order.<sup>7</sup> To request a hearing, you must send a written hearing request to the OCCC no later than 30 days after service of this Order. <sup>8</sup> You must send your request to Audrey Spalding, Assistant General Counsel, by mail to 2601 N. Lamar Blvd., Austin, Texas 78705, or by email to audrey.spalding@occc.texas.gov.

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.<sup>9</sup> If you fail to request a hearing by the deadline, this Order will be considered final and enforceable.<sup>10</sup>
