ORDER TO FILE TIMELY AND ACCURATE QUARTERLY AND ANNUAL REPORTS

The Office of Consumer Credit Commissioner ("OCCC") issues this Order to File Timely and Accurate Quarterly and Annual Reports against Your Money Tree, LLC d/b/a Your Loan Depot ("Loan Depot").¹

Statement of Facts and Law

Loan Depot is a credit services organization licensed to act as a credit access business under Chapter 393 of the Texas Finance Code. Loan Depot operates under master file number 1400050023 at multiple licensed locations, under license numbers, 151844, 151845, 151846, and 151849. Loan Depot's compliance officer is Brooke Fountain, and its designated contact address is 1401 N. Frazier St., Conroe, Texas 77301.

A credit access business must file quarterly and annual reports with the Consumer Credit Commissioner ("Commissioner").² A credit access business must submit for each of its licensed locations its 2021 2nd quarter report on or before July 31, 2021.³ All information provided on the quarterly and annual reports must be accurate and calculated in accordance with the OCCC's instructions.⁴

Loan Depot did not file its 2021 2nd quarter report with the Commissioner on or before July 31, 2021.

The Commissioner may issue an injunction ordering a credit access business to file one or more complete, accurate, and timely quarterly or annual reports if the Commissioner has reasonable cause to believe that the credit access business is violating Chapter 393 of the Texas Finance Code.⁵

The Commissioner has reasonable cause to believe that Loan Depot is violating Chapter 393 of the Texas Finance Code, and therefore issues this Order, because Loan Depot failed to timely file its 2021 2nd quarter report.

Order

IT IS ORDERED that Your Money Tree, LLC d/b/a Your Loan Depot:

- 1. comply with, and cease and desist from violating, the reporting requirements set forth in Section 393.627 of the Texas Finance Code and Title 7, Section 83.5001 of the Texas Administrative Code;
- 2. file its 2021 2nd quarter report within 30 days of service of this Order, if it has not already done so; and
- 3. timely file complete and accurate future quarterly and annual reports.

Credit access business quarterly and annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.

Violation of Order

You may be assessed an administrative penalty of up to \$1,000 for each day of violation of this Order.⁶ Multiple violations may also result in the suspension or revocation of your license.⁷

Right to Request Hearing

If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code.⁹ If you fail to request a hearing by this deadline, this Order is considered final and enforceable.¹⁰
