## ORDER IMPOSING ADMINISTRATIVE PENALTY

The Office of Consumer Credit Commissioner ("OCCC") issues this Order Imposing Administrative Penalty against High Bell Investments LLC d/b/a Kwik Cash Pawn ("Kwik Cash Pawn").1

#### Statement of Facts and Law

Kwik Cash Pawn is a pawnshop licensed by the OCCC under Chapter 371 of the Texas Finance Code. Kwik Cash Pawn operates under master file number 1600057053 at one licensed location, under license number 157413. Kwik Cash Pawn's compliance officer is Shawn High, and its designated contact address is 401 W. Hwy. 190, Copperas Cove, Texas 76522.

A pawnshop must file annual reports with the Consumer Credit Commissioner ("Commissioner").<sup>2</sup> A pawnshop must comply with all instructions from the OCCC relating to submitting the report, and must file a report for each licensed location.<sup>3</sup> The report is due by July 31 for the prior calendar year's activity.<sup>4</sup>

On December 6, 2018, the OCCC issued an Injunctive Order to File Timely and Accurate Annual Reports (the "Order") against Kwik Cash Pawn for violating Chapter 371 of the Texas Finance Code by failing to timely file its 2017 annual report. The Order required Kwik Cash Pawn to timely file all future annual reports.

Kwik Cash Pawn did not file its 2020 annual report by July 31, 2021, for one licensed location, under license number 157413.

The Commissioner may issue an injunction ordering a pawnshop to file one or more complete, accurate, and timely annual reports if the Commissioner has reasonable cause to believe that the pawnshop is violating Chapter 371 of the Texas Finance Code.<sup>5</sup> The Commissioner may impose an administrative penalty on a pawnshop that violates an injunction.<sup>6</sup>

By failing to timely file its 2020 annual report, Kwik Cash Pawn has violated Chapter 371 of the Texas Finance Code and the OCCC's Injunctive Order to File Timely and Accurate Annual Reports.

### Order

IT IS ORDERED that High Bell Investments LLC d/b/a Kwik Cash Pawn:

- 1. pay an administrative penalty in the amount of **\$500.00**, calculated as \$500.00 each for Kwik Cash Pawn's one licensed location, within 30 days of the date of this Order; and
- 2. file its 2020 annual report within 30 days of the date of this Order, if it has not already done so.

Pawnshop annual reports must be submitted through the OCCC's Application Licensing Examination and Compliance System (ALECS): alecs.occc.texas.gov. Instructions are available by clicking the "File Annual Report" button on the OCCC's home page, occc.texas.gov.

# Right to Request Hearing

You have the right to request a hearing regarding this Order.<sup>7</sup> To request a hearing, you must send a written hearing request to the OCCC no later than 30 days after the date of this Order.<sup>8</sup> You must send your request to Matthew Nance, Deputy General Counsel, by mail to 2601 N. If you request a hearing, a hearing on this matter will be set and conducted in accordance with Chapter 2001 of the Texas Government Code. If you fail to request a hearing by the deadline, this Order will be considered final and enforceable. In
